2024 | HIGHLIGHTS

JANUARY 14 TH	In a press conference, SOCMA President and CEO Jennifer Abril joins with representatives of Congress, the National Security Council, and the Cybersecurity and Infrastructure Security Agency, calling for the reinstatement of the CFATS program.
JANUARY 21 ST	The Senate Committee on Environment and Public Works holds a hearing on the Toxic Substances Control Act with a focus on EPA's failure to complete reviews of new chemical submissions in the congressionally mandated timeframe.
JANUARY 25 TH	SOCMA and members of the Health and Safety Committee meets with the White House on the Hazard Communication Standard.
APRIL 1 ST	SOCMA signs letter to House and Senate leadership illuminating the problems in EPA's proposed Risk Management Program Rule.
MAY 7 TH	House Committee on Energy & Commerce holds a hearing on EPA's proposed Risk Management Program Rule.
MAY 10 TH	SOCMA and co-petitioners sue EPA on the Risk Management Program rule.
JUNE 11 TH	SOCMA's Board of Governors meets with Senate Committee on Environment and Public Works to discuss challenges facing the industry including bringing new chemicals to market through EPA's New Chemicals Review Program under the Toxic Substances Control Act.
JUNE 11 TH	SOCMA's Board of Governors meets with the House of Representatives, Committee on Energy & Commerce for a dialogue about challenges with TSCA, EPA's Risk Management Program rule, and reauthorization of the Chemical Facilities Anti-Terrorism Standards.
JUNE 13TH	SOCMA staff meets with the Assistant U.S. Trade Representative to advocate for the reinstatement of a fair and transparent exclusion process for Section 301 tariffs.
JULY 15 TH	SOCMA Advocacy Committee members meets with the White House on EPA's proposed TSCA Procedural rule.
JULY 22 ND	SOCMA staff meets with Speaker of the House Mike Johnson's staff to discuss the Speaker's legislative priorities for the remainer of the 118th Congress.
OCTOBER 29 TH	SOCMA Board of Governor's meets with the Department of Commerce, Deputy Assistant Secretary Tyler Beckelman related to supply chain challenges hampering the industry.
DECEMBER 10TH	SOCMA staff meets with OSHA Administrator Doug Parker to discuss the transition to the new administration.
DECEMBER 12TH	SOCMA staff meets with the legislative and policy team of Senate Majority Leader Mitch McConnell to discuss their outlook on the "lame duck" session.
